NOTICE OF RACE

1. ORGANISING AUTHORITY

2. PLACE AND EVENT SCHEDULE

The regatta will be raced in the waters off the Fraglia Vela Malcesine with the following timetable:

Thursday, August 12 th	Registration 9.00 – 12.30; 14.30 – 18.30
Friday, August 13 th	Registration until 10.00 Skippers meeting and distribution of ribbons at 11.00 First warning signal at 13.00; Races
Saturday, August 14 th	Races
Sunday, August 15 th	Races; Prize-giving at the end of the races

3. RULES

3.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS) 2009-2012 and by the current sailing regulations defined by the FIV in Italy for 2010.

3.2 The exception of RRS 61.1 (a)(2) will not be applied: i.e. the use of the red flag will be obligatory.

3.3 Appendix "P" of RRS will apply (Special Procedures for Rule 42).

4. ADVERTISING

According to Class Rules, no publicity exceeding the standard provided for in ISAF Regulation 20 will be permitted.

5. ELIGIBILITY

The regatta is open to all the helmsmen born during the years: 1995 - 1996 - 1997 - 1998.

Italian participants must be registered as a full member of the F.I.V. with appropriate medical certificate as well as membership of the Optimist Class Association (AICO) for 2010.

Foreigner participants shall comply with the rules of their own countries. The licences shall be submitted to the Regatta Office when registering.

6. REGISTRATION

Entry forms must be sent on-line through the website www.fragliavela.org, by 08th of August 2010.

The completion of Registration shall be made at the Regatta Office before 10.00 a.m. on Friday 13/08/2010.

Entry fee: € 45,00.

7. INSURANCE

All boats must be insured for Third Party damage as specified in paragraph "C.1 INSURANCE" according to current sailing regulations defined by the FIV in Italy for 2010 with a minimum cover of € 1.000.000,00. The insurance policy or a valid substitute for it must be given to the Regatta Office when registering.

8. MEASUREMENT CERTIFICATE

All participating boats must have a certificate of conformity to class rules. Boats must compete under their certified sail numbers: any changes may be authorized by the Regatta Committee at their discretion.

9. NUMBER OF RACES AND CLASSIFICATION

If possible, 8 races are scheduled, a maximum of 3 races may be sailed in the same day. The classification will be based on Normativa Generale FIV for Sports Organised in Italy in 2010.

10. COACHES AND SUPPORTERS

All Coaches and Supporters must complete a Registration Form available from the Regatta Office detailing the kind of boat they will be using, accepting the "Rules for Coaches and support boats" as described in the Sailing Instructions and declaring which sailors they will be supporting.

Registered coaches will be subject to the technical directives and disciplinary procedures of the Race Committee and the Jury who have the power to revoke their permission to be in the Race Area.

11. HOSPITALITY

11.1 Boats trailers and cars may park in the sailing club grounds from Monday, August 09th until Wednesday, August 18th. Outside the above mentioned period the tariffs of the 2010 price-list will apply.

11.2 **It is not possible to park Camper Vans, either during the day or overnight, within the confines of the Fraglia Vela Malcesine.**

12. SAILING INSTRUCTIONS

The Sailing Instructions will be issued to each competitor at the Regatta Office from 12/08/2010.

13. PRIZES

- "Simone Lombardi" Trophy to a participating Club;
- "Meeting Internazionale Degli Ulivi" Trophy to a Club, combined with the classification of the "Ora Cup Ora" Regatta held at the Arco Sailing Club;
- Prizes to the first 10 places in the overall classifications;
- Prizes to the first 3 in the women's classifications;
- Participation prizes awarded to all competitors.

14. DISCLAIMER

As specified in Rule 4, all competitors will participate in the Regatta, for which this is the Notice of Race, at their own risk and will be responsible to themselves for their decision to take part and continue in the Regatta. The Organisers decline any responsibility for any damage caused in whatsoever way to people and/or objects during the Regatta period, whether on land or water, as a result of their participation in this event as specified in these Sailing Instructions. It is up to each competitor to decide, based on strength of wind, their ability, weather forecasts and all other elements of being a competent sailor, whether they go out on the water to participate or continue in the Regatta or not.

15. PHOTOGRAPHY AND FILM RIGHTS

Competitors concede full rights and permission to the Organisers to publish and/or transmit via various media methods, without the competitors having any right to recompense, any photos or film footage taken during the Regatta, including but not limited to Television advertising, and to be used for editorial, advertising or published information purposes.
